On behalf of Complainants and Respondents in Investigation No. 337-TA-853, we are writing regarding the Notice Of Commission Determination To Review In Part A Final Initial Determination Finding No Violation Of Section 337, issued on November 25, 2013 (the "Notice").

The Notice sets a deadline of December 23, 2013, for the parties to file initial written submissions in response to the four questions posed by the Commission, and a deadline of December 30, 2013, to file reply submissions. In addition, the Notice extends the Target Date for this Investigation from January 6, 2013 to January 29, 2014.

Complainants and Respondents respectfully request a brief extension of time for the private parties and the Office of Unfair Import Investigations ("OUII") to file their reply submissions.
