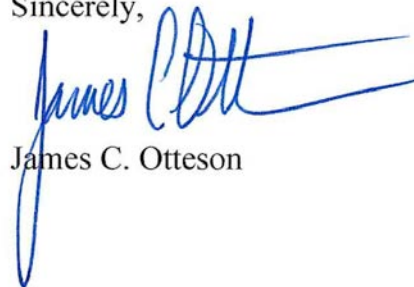

Dear Secretary Barton:

On December 23, 2013, third parties Sprint, CTIA, and U.S. Cellular Corporation each filed a Statement Regarding the Public Interest pursuant to the Notice of Commission Determination dated November 25, 2013. However, unlike Sprint, which properly served Complainants, CTIA and U.S. Cellular Corporation failed to do so. As a result, Complainants were unaware that these two public interest statements existed until having seen citation references from Respondents' reply brief.

Complainants did not have an opportunity to respond to these public interest statements. Nonetheless, these statements do not offer any new substantive arguments not already made by Respondents or Sprint. Accordingly, Complainants request that their rebuttal to Respondents' and Sprint's public interest statements (as discussed in Complainants' Reply Brief) be considered to apply similarly as a rebuttal to these additional public interest statements.
