 2 Scientific Corporation (“Plaintiffs”) submit this Statement to notify the Court of Plaintiffs’
 3 nonopposition to Barnes & Noble, Inc.’s Motion for Administrative Relief for Permission to File
 4 Reply Brief. *See* Dkt. No. 101.

5 At the time of the filing of Barnes & Noble, Inc.’s Motion for Administrative Relief for
 6 Permission to File Reply Brief, Dkt. No. 101, Phoenix Digital Solutions LLC had notified Barnes
 7 & Noble, Inc. that it would oppose the motion unless Barnes & Noble, Inc. would agree not to
 8 oppose a motion by Plaintiffs for similar administrative relief, i.e., for permission to file a sur-
 9 reply regarding the same new material identified in Barnes & Noble Inc.’s reply. While an initial
 10 agreement between the parties could not be reached, a compromise was reached in subsequent
