**NOTICE OF INTENT TO BECOME A LICENSEE OBJECTOR**

Toshiba Corporation, Toshiba America, Inc., Toshiba America Electronic Components, Inc., Toshiba America Information Systems, Inc., and Toshiba America Consumer Products, LLC (collectively, "Toshiba") file this Notice of Intent to Become a Licensee Objector and respectfully state as follows:

1 Toshiba is party to one or more patent license agreements with the Debtor<sup>1</sup> and, as a  
2 licensee, is a party-in-interest.

3 On January 8, 2015, the Debtor and Official Committee of Unsecured Creditors filed the  
4 *Joint Plan of Reorganization by Official Committee of Unsecured Creditors and Debtor* [Docket  
5 No. 637] (the “Plan”). The Plan indicates that a party may become a Licensee Objector, to be  
6 included on Exhibit B to the Plan, “at any time prior to the commencement of the Confirmation  
7 Hearing by notice to counsel for the Debtor and the Committee.” Toshiba is not currently listed as  
8 a Licensee Objector. Toshiba hereby provides notice of its intention to be a Licensee Objector
