23 **NOTICE IS HEREBY GIVEN** of the following:

24 1. On March 20, 2013 (the "Petition Date"), Technology Properties Limited LLC (the  
25 "Debtor") commenced the above-entitled Chapter 11 bankruptcy case by filing a Voluntary Petition  
26 in this Court.

27 2. A trustee has not been appointed for the Debtor, and it continues to function as the  
28 debtor-in-possession pursuant to 11 U.S.C. §§ 1107 and 1108.

1           3.       On March 28, 2013, the Office of the United States Trustee appointed the Official  
2 Committee of Unsecured Creditors (the "Committee") in this case, pursuant to 11 U.S.C. § 1102.

3           4.       On January 13, 2014, the Committee filed the MOTION FOR ORDER GRANTING LEAVE,  
4 STANDING AND AUTHORITY TO COMMENCE AND PROSECUTE CLAIMS OF THE DEBTOR'S ESTATE  
5 [Docket No. 360] (the "Motion"). The Motion requests, among other things, that the Court enter an  
6 order (a) granting leave, derivative standing and authority in the Committee to investigate,  
7 commence and prosecute actions against certain of the Debtor's insiders and affiliates; and (b)  
8 directing the Debtor to provide the Committee with unfettered access to all of the books, records,  
9 and other documents in the possession, custody, or control of the Debtor. The Motion is based on  
10 this Notice, the Declarations filed in support thereto, the pleadings and papers on file herein and  
11 upon such oral and documentary evidence as may be presented at the hearing on the Motion.

12           5.       A hearing to consider approval of the Motion will be held on **February 26, 2014 at**  
13 **2:00 p.m. (Pacific Standard Time)** before the Honorable Stephen L. Johnson, United States  
14 Bankruptcy Judge, United States Courthouse and Federal Building, 280 S. First Street, Room 3099,  
15 San Jose, CA 95113.

16           6.       Pursuant to 9014-1(c)(1) of the Bankruptcy Local Rules for the Northern District of  
17 California, the deadline for serving and filing of written objections to the Motion is fourteen (14)  
18 days in advance of the hearing (February 12, 2014), and the deadline for serving and filing of written  
19 replies to any such objections is seven (7) days in advance of the hearing (February 19, 2014).

20           7.       Creditors and parties in interest with questions or who desire copies of the Motion  
21 may contact counsel for the Committee at the contact information provided at the top of the first  
22 page of this notice.
