21 **ORDER GRANTING JOINT EX PARTE APPLICATION TO EXTEND**  
22 **DEADLINE FOR FILING DISCLOSURE STATEMENT**

23 The Court has considered the Joint Ex Parte Application to Extend Deadline for Filing  
24 Disclosure Statement (the "Application") submitted by debtor and debtor in possession  
25 Technology Properties Limited LLC ("TPL") and the Committee of Unsecured Creditors (the

1 “OCC”). The Court has considered the Application and, for good cause shown, hereby  
2 GRANTS the Application.

3 IT IS THEREFORE ORDERED that

4 1. The Applicants have a 48-hour extension of the deadline to file their  
5 Disclosure Statement Re: Joint Plan of Reorganization by Official Committee of Unsecured  
6 Creditors and Debtor (September 4, 2014), from noon on September 15, 2014, to noon on  
7 September 17, 2014.

9 ~~2. If the Joint Disclosure Statement is filed by the date and time set forth above,~~  
10 ~~then the last day to object to the Joint Disclosure Statement shall remain September 29, 2014,~~  
11 ~~and the hearing on approval of the Joint Disclosure Statement shall be October 2, 2014, at~~  
12 ~~3:00 p.m.~~

15 2. Given the already truncated schedule, the extension leaves creditors with insufficient  
16 time to review the disclosure statement/plan, and any extension to the opposition period would  
17 leave the court with insufficient time to review. Thus, the date for filing objection to the  
18 approval of the disclosure statement is EXTENDED to October 1, 2014, and the hearing on the  
19 approval of the joint disclosure statement is CONTINUED to October 14, 2014 at 2:00 p.m.

20 3. Other matters set for hearing on October 2, 2014 will go forward as scheduled.
